IIT Jammu invites online applications from qualified Indian Nationals for filling up following post on **Outsource basis through manpower agency.**

1. The Civil Engineering department requires one Laboratory Assistant, who will work in Environmental Engineering laboratory and help in conducting experiments/tests on water quality parameters such as pH, conductivity, hardness, BOD, COD, etc and air, noise quality monitoring.

2. **Eligibility Criteria**

Qualification/Experience: -

i. Master Degree in Civil Engineering or equivalent qualification in appropriate field with a minimum of 60% marks in the qualifying degree from a recognized University/Institute.

OR

Bachelor's Degree in Civil Engineering with a minimum of 60% marks in the qualifying degree from a recognized University/ Institute with two years relevant experience.

OR

Three years Diploma in Civil Engineering (after 10+2) with a minimum of 60% marks in the qualifying degree from a recognized University/Institute with two years relevant experience in NABL/accredited laboratory or research facility.

ii. Preference will be given to those who have at least 60% marks in all Boards/ University examinations or having work experience in NABL certified labs.

3. **Key responsibilities:** The Laboratory assistant (LA) will assist the students in conducting the experiments. LA will also assist faculty members in conducting field/site tests if required and in developing new testing facilities for department.

4. **GENERAL INSTRUCTIONS**

- (i) Candidates should read carefully the requisite minimum essential qualifications, age and eligibility, experience criteria etc. laid down in the advertisement before applying for the relevant post.
- (ii) The engagement shall be purely on **outsource basis through manpower outsourcing agency of the Institute** and period of engagement shall be purely dependent on the requirement of the Institute. The salary will be paid through Manpower agency contracted by IIT Jammu. Please note that this is purely a temporary appointment, and selection does not entitle for any claim what-so-ever of permanency or regularization against any regular post or any vacancy arising in future in this or any other cadre/post on the basis of this service. The Institute can fix the consolidated salary lower/ higher than the given range.
- (iii) No claim for any service benefit like PF, Pension, Gratuity, Medical Allowance, Seniority & Promotion etc. from this contract appointment will be admissible.
- (iv) There is no application fee for Application forms.
- (v) Good knowledge of Computer applications (on emails, word processing, spreadsheet, presentations software etc. and OS like MS-Windows) is a must.
- (vi) Shortlisted candidates shall be called for Trade Test/Interaction evaluation.
