Pay Scale HAG Rs. 67,000/- (increment @3% per annum) Rs. 79,000/- (pre-revised Scale)

As per Recruitment Rules the post of Assessor is filled up by deputation ( including short term contract ) / re-employment basis in the following manner :-

#### **Deputation (including short term contract )**

Officer under the Central / State Governments/UT/PSUs/ Autonomous / Semi Govt./ Statutory Organizations etc. (i) holding analogous post on regular basis OR holding a post in the pay band iv + GP Rs. 10000 (or equivalent in the pre-revised scale) with 3 years regular service in the grade OR Officer with 25 yrs. regular service in Group 'A' post in the service out of which atleast 1 year regular service should be in the SAG AND (ii) B.E. (Civil Engineering) from recognized University or equivalent AND (iii) Having at least fifteen years experience in Irrigation projects / Water Management / Inter State Water Disputes .

Officer under the Central Government / State Governments/ UT Govt. including State Judicial Services / PSUs/ Autonomous / Semi Govt./ Statutory Organizations etc. ( i ) having Graduate degree from recognized University or equivalent ; AND ( ii) Holding analogous post on regular basis AND ( iii ) having atleast 5 years experience of handling Establishment, Administration and Accounts matters. Preference shall be given to the Law Graduates with knowledge of legal matters and procedures and experience of court proceedings.

Note: Period of deputation / contract including the period of deputation / contract in another ex-cadre post held immediately preceding this appointment in the same or some other organization / Department of the Central Government shall ordinarily not exceed 3 years or till the life of the KWDT or till further orders whichever is earliest. The maximum age limit for appointment by deputation including short term contract shall not be exceeding 56 years.

Officers under the Central Government / State Governments/ UT/PSUs/ Autonomous / Semi Govt./ Statutory Organizations etc. i) a Graduate from recognized University or equivalent having a speed of 120 words per minute in shorthand; AND ( ii) Holding analogous post on regular basis OR holding a post in the pay scale of Rs. 15600-39100 + GP 5400 (equivalent pay Matrix level-10 as per 7<sup>th</sup> CPC ) with five years regular service in grade OR holding a post in the Pay Scale of Rs. 9300-34800 + GP Rs. 4800 (or equivalent in pre-revised scale) with six years regular service in the grade OR holding a post in the Pay Scale Rs. 9300-34,800/- +GP-4200 (or equivalent in the revised scale) with ten years regular service in the grade.

Beyond that, the term of incumbent can be extended further for a period of not more than six months on the same terms and conditions in public interest, if required.
