1. <u>COMPANY PROFILE</u>

IRSDC is a Special Purpose Company created by Ministry of Railways (MoR) as a JV company of Rail Land Development Authority (RLDA), a statutory authority under the Ministry of Railways and IRCON, a Central Public Sector Enterprise (CPSE) under MoR in 2012 with equity participation from RLDA and IRCON in the ratio of 49:51 ratio. Subsequently, it has been converted into a joint ownership Company of Rail Land Development Authority (RLDA) and IRCON International Ltd (IRCON) with 50:50 ownership as an independently Board run company. As per union cabinet approval redevelopment/development of all railway stations over Indian Railway network is to be carried out through IRSDC as the nodal agency. IRSDC is also the main/ project development agency (PDA) for development of stations over Indian Railway Network. The objective of the Company is to take up redevelopment of railway stations and maintaining them on the pattern of airports. IRSDC is required to draw upon the success stories the world over, adopt a suitable revenue model and target redevelopment of stations across India. IRSDC is to develop stations on self-financing model so that new infrastructure at stations along with its maintenance is to be mainly financed by commercial development of land and airspace.

2. <u>SELECTION PROCESS</u>
