7. In case of non availability of resident doctors as per Residency Scheme order dated 1992 the relaxed eligibility criteria as per instructions contained in circular no. F. No. 121/26/2010/H&FW/1996-2045 Dated 10.06.2011 of Health & Family Welfare shall be observed for filling up the vacant post.

TERMS AND CONDITIONS:

8. NO TA/DA will be paid for appearing in the interview.
9. OBC candidates are required to submit their caste certificate (issued before the date of application) issued by the Govt. of NCT of Delhi and shall have declared non creamy layer status on the day of the interview on prescribed format.
10. In case of non-availability of SC/ST/OBC candidates, the post shall be filled from General category.
11. Selected candidates shall be allowed a maximum of 07 days time for accepting the offer of appointment and thereafter 07 days for joining from the date of acceptance, failing which the offer shall stand cancelled.
12. **Duties and responsibilities:** - The hospital shall fix duties and responsibility of all SRs & JRs from time to time. They will be required to perform such work as may be needed in legitimate interest of patient care.
13. The appointment will be initially for a period of 89 days or till a regular candidate joins whichever is earlier. Extension is subject to satisfactory work conduct report and vacancy.
14. Appointment shall be subject to Medical Fitness & Verification of certificates of Educational Qualifications/Age/Caste/DMC registration and Internship completion certificate.
15. The service will be governed by Residency Scheme of Govt. of India & Civil Services (Temporary Rules 1978).
16. Candidates are required to bring all original certificates and testimonials with their attested photocopies along with one passport size photograph on the date of interview.
17. The decision of the Selection Board/Medical Supdt. PMMMMH regarding selection will be final and binding and no representation will be entertained in this regard.
18. If any declaration/information furnished by the candidates is found false or any material/fact suppressed willfully, the candidate/appointment will be cancelled/terminated forthwith.
